NOTE: LAST DATE FOR ENROLMENT OF 8th CLASS IS DECEMBER 9, 2019.

1. If an institution fails to submit enrolment forms up to 08/11/2019, a penalty @ Rs.05/- (Rupees Five) per day per student shall be charged w.e.f.10-12-2019 to 31-12-2019.
2. The Heads of the institutions are advised to adopt the procedure of **online enrolment** through Board's website(www.bisekt.edu.pk/g8) for 8th class regular students and submit along with requisite fee within due date to this office for confirmation physically ,otherwise fee shall be charged as per online system record. **Manual Enrolment return shall not be accepted. 3. The age limit for a candidate will be Thirteen (13) years on the commencement date of (8th Class) Middle Standard School (Annual) Examination, 2020.
4. The Heads of the Institutions are directed to submit the following documents of migrated students from other boards within **fortnight** for enrollment to this office. If an institution fails to provide the same, a penalty would be **imposed on the institution.**
(A) Original Migration Certificate
(B) Countersigned copy of School Leaving Certificate.
(C) Enrolment form/return along with reference letter duly signed by the Head of institution concerned
(D) Prescribed Fee.
5. A student will not be admitted or enrolled until **Original School to School Migration Certificate and School Leaving Certificate** are submitted, in case of non provision of the above; the penalty will be imposed on the institution.
6. School to School Migration(Local Migration) shall not be allowed under any situation after December 31, 2019 till the declaration of annual Middle Standard School Examination Result 2020.
7. **All the students seeking migration are required to submit photocopy of School Leaving Certificate (S.L.C) along with prescribed form.**
8. **The Heads of the Institutions are advised never to sign migration form after due date i.e. December 31, 2019. In such situation Board is authorized to reject or take disciplinary action.**
9. **The Heads of the Institutions are advised to deposit the enrolment fee for the session 2019-2020 in NBP branches within the jurisdiction of BISE Kohat.**
10. The Heads of Govt Institutions are advised to deposit annual renewal/extension fee for the session 2019-20 in NBP Branch within the jurisdiction of BISE, Kohat while the **Private Institutions shall renew/extend their registration with KPPSRA.**
